I, on behalf of the Board of Trustees welcome all of you to the 23<sup>rd</sup> Annual General Body Meeting of the Trust and place this Annual Report, which reveals the detail activities and programme of our Organisation for the Year; 2018-19. The Trust has completed its 22<sup>nd</sup> Year of working since the date of its registration as a Public Trust, vide Regd. No: 1178/96.

**Vision of the Trust:** Empowering persons with Disabilities, i.e. to provide all sorts of modern comfort and facilities to the Different Able Children/Person like normal person without any discrimination, so as to bring them into main stream of the society. Keeping the above vision in view, the Board of Trustees are taking all possible steps to achieve the above goal. The main constraint to achieve the above objectives is financial deficit, and the Board of Trustees have taken a vow to overcome it by hook or crook.

**Memberships:** Now the membership of the Organisation has been restricted to life members only and the total membership strength is 42 at present.

## **Activities of the Organisation:**

**Meeting:** Three meeting of the Board Trustees and one of G. B. Meeting of the Trust has been held during the period under report. Two representatives of the Organisation attended Zonal Meeting of Parivaar at Bodhagaya during August, 2018. One parents awareness meeting was also held during the period under report. Managing Trustee along with another member of the Board of Trustees attended the 27<sup>th</sup> National Parents Meet of Parivaar at Ahmedabad, Gujurat on 19<sup>th</sup> and 20<sup>th</sup> October 2019.

**Holding of Young Athlete Programme of Special Olympics Bharat:** - The Organisation is conducting Young Athlete Programme of Special Olympic Bharat at Athgarh since April, 2019.

**Holding of Parivaar Network Programme for Mentors and Self Advocates Training at Gharaunda Projects of Athagarh:** The Programme was conducted quite successfully by the Organisation during the period from 13<sup>th</sup> April, 2109 to 25<sup>th</sup> May, 2019 at Athagarh. Mr. Ananga Negi, Master Trainer, Self Advocates Programme and Project Coordinator, D.A.PP.W.D, Subarnapur had inaguarated the above Programme on 13/04/2109.

The Centre provides Primary and Vocational Training to the Mentally Retarded Children and takes up research and rehabilitation programmes.

**Gharaunda Project:** As all of you know that the project is running at "DORADA" , Athagarh in Cuttack District since 2006 with much financial hardship and all possible steps have been taken to obtain financial support from the National Trust, New Delhi.

**Application for State Govt. Grant:** Application for financial assistance from the State Govt. is also pending for consideration and sanction.

**Effect of Cyclone "Fani":** Compound walls of the premises of "Gharaunda" project at DORODA, Athagarh has been damaged due to sever Cyclone, 'Fani; so also many trees along with garden of the Center has been affected due to the above cyclone .Steps have been taken to obtain funds for repair of the damaged portions.

**Financial Position;** The Audit Report for the financial year, 2018-19 which has been circulated, will reveal the detail financial position of the Organisation. The present financial position of the Trust has been seriously affected due to non-release of funds from the National Trust towards Gharaunda project; it is observed that the Gharaunda project is maintained with many difficulties by way of raising huge loans and donation.

Last but not the least; I thank all the members, invitees, well wishers and donors for their sincere cooperation and participation in different programmes of the Trust, which is highly commendable.
